**ORDER:-**

The Union Finance Minister in the Budget speech for 2007-08 has announced that 1396 Government Industrial Training Institutes in the country will be upgraded by providing an interest free loan of Rs.2.5. crores to each Industrial Training Institute in a Public Private Partnership mode.

2. Under the Government of India scheme of upgradation of Government Industrial Training Institutes throughout the country by providing an interest free loan of Rs.2.5 crore to each Industrial Training Institute in a Public Private Partnership mode, 24 Government Industrial Training Institutes in Tamil Nadu have already been upgraded through the

Public Private Partnership Mode for the year 2007-2008 and 2008-2009 in the G.O.s first and second read above, respectively.

3. The Director General of Employment & Training, New Delhi in his letter third read above, has stated that 12 Government Industrial Training Institutes have been tentatively allocated for Tamil Nadu for upgradation under the PPP mode during the year 2009-2010, and has requested to send atleast 25% more number than indicated.

4. Accordingly, based on the recommendation of the SSC meetings held on 03.09.2009 and 10.02.2010 to select Industry Partners, the Commissioner of Employment and Training in his letter seventh read above, has recommended for the Selection of the following Industries Partners noted against each Government Industrial Training Institute for upgradation under the PPP Mode and requested the Government to issue orders in this regard.

5. Further, as per the instructions/ guidelines issued by the Government of India, the Commissioner of Employment and Training has also requested the Government to issue orders on the following:-

- (I). For the conversion of constituted/ reconstituted Institute Management Committees into registered Societies for the 3 Government Industrial Training Institutes, Mudukulathur, Chidambaram, Sankarapuram and BTC Ambattur to be upgraded through Public Private Partnership.
- (II). Administrative and financial powers to the Institute Management Committees as provided in para 4 (c) of section B of the Memorandum of Agreement.
- (III). For opening a bank account in a Public Sector bank in the name of the Society for getting interest free loan from the Government of India.

6. After careful examination, the Government accept the proposal of the Commissioner of Employment and Training. Accordingly, the Government select the following Industry Partners noted against each Government Industrial Training Institutes for the implementation of upgradation of Government Industrial Training institutes under Public Private Partnership Mode, during 2009-2010.


